Manufacturer (if business is an authorized Dealer/Agent)

- Pages of bids must be pre-numbered and initialed
- Bids must be signed and stamped by an authorized personnel
- Bids must be submitted in English
- All Bid prices must be quoted in United States Dollars
- Bidders must quote Duty-Free price
