### INVITATION FOR BIDS

The FSM Department of Transportation, Communications and Infrastructure (FSM DTC&I) is inviting interested contractors to submit sealed bid proposals for the construction of the Kosrae International Airport New Electrical Vault, in the State of Kosrae, Federated States of Micronesia. Sealed bids will be received by the FSM DTC&I in Palikir, until 4:00 p.m., Pohnpei, FSM time, Friday, June 21, 2019 at which time all bids will be publicly opened and read aloud. Bid envelopes shall be clearly marked the project name "Kosrae International Airport New Electrical Vault" upon submission. Bid proposals sent by mail must be sent to the address below.

In order to be considered, the bid proposals must be received and stamped by FSM DTC&I office no later than the above designated time and date. It is the bidder's responsibility to ensure that bids sent through the post office or other courier services are received and stamped by FSM DTC&I no later than the designated deadline.

The bid due date will NOT be extended.

Bidding packages are available at the FSM DTC&I, in Palikir, Pohnpei phone: 011-691-320-2865/1422. Each proposal must include a Bid Guarantee, in the amount of five percent (5%) of the aggregate of the proposal. The bid guarantee is refundable after execution of the contract with the successful bidder.

All bidders are required to submit a Contractor's Qualification Statement in addition to the Bid. The Contractor's Qualification Statement shall be submitted in a separate sealed envelope from the bid by 4:00 p.m. Pohnpei, FSM Time, Friday, June 21, 2019 to the FSM DTC&I in Palikir, Pohnpei FSM. Contractors will be notified regarding the status of their qualification. If deemed qualified, contractors will be asked to submit a bid.

A Pre-Bid Conference is scheduled to be held on Friday, May 31, 2019 at 4:00pm, at the job site. All questions or concerns by the bidders are to be presented at the Pre-Bid Conference. Bidders desiring to bid on this project and attend the Pre-Bid conference should make airline reservations immediately as space is limited on flights into and out of Kosrae.

The FSM DTC&I reserves the right to reject any or all bids or to waive any informality in the bid documents. No bid shall be withdrawn for a period of one hundred twenty (120) days following the bid opening date without the consent of the Contracting Officer.
